Consultation notice wording

Council for World Mission (UK) (charity number 1097842) ("CWM UK")

CWM UK is the trustee of two funds:

- The Council for World Mission Missionaries Support Fund this is a consolidation of a number of separate historic funds, the oldest of which dates back to 1910
- Harold Granger Bequest this was established by a legacy left in 1937

Both of these funds are what is known as "permanent endowment", which means the capital of each fund has to be retained and only the income return on investment of that capital can be spent for the particular purposes of each fund.

Both funds date back around a century to a time when the work of CWM was very different than it is today. The current purposes of each fund are relatively narrow and out of date, and it is the view of the CWM UK trustees that the purposes and use of the funds ought to be updated in order to allow those funds to be used most effectively.

CWM UK is proposing to make changes to both of these funds in order to allow them to be used more flexibly to support the missionary work of CWM and the member churches more generally, and in particular to enable them to be used towards the Missionary Support Programme (MSP).

CWM has been running our MSP in phases for several years. The currently active MSPs are MSP (II) to MSP (IV). We plan to launch the latest MSP (V) in 2026. The vision of MSP (V) is to engage in God's mission in a renewed way, focusing on accompanying, empowering, and learning from marginalized communities. The key objectives are:

- Enhancing the capacity of member churches through leadership development, theological formation, and practical skills training.
- · Adopting an equitable approach to resource sharing, recognizing the diverse contexts of member churches.
- Fostering a participatory and collaborative mission culture, where churches are not isolated actors but part of a global network of solidarity. MSP (V) will cultivate spaces for shared discernment, exchange of best practices, and collective mission engagement.

It is proposed to:



- change the purposes of each fund; and
- · release the "permanent endowment" restrictions so that the capital and the income of each fund can be spent for the fund's purposes.

CWM UK will need to seek the prior approval of the Charity Commission before these changes can become effective.

Reasons for the change of fund purposes and the release of permanent endowment

CWM UK believes that the current purposes are no longer appropriate, as they are unduly restrictive and do not reflect a 21st century approach to missionary work or to the development of missional congregations within the member churches of CWM.

CWM UK therefore proposes to amend the purposes of each fund as set out below to better reflect 21st missionary activities and make specific reference to the Mission Support Programme.

As permanent endowment funds, only the income of each fund can be applied towards the purposes. However, the reality of the 21st century financial market is that income returns on investment which ared CWM's main source of income and funding, are becoming increasingly more volatile and less consistent. Releasing the permanent endowment funds towards the MSP fulfil the purposes of the fund in a meaningful way without the need to drawing down on our general fund. CWM UK therefore proposes to release the permanent endowment restrictions over each fund. This means that the funds will still be **restricted** towards their respective purposes, but both the income and the capital can be spent.
